Sub: Complaint against the arrested accused persons namely Durgadas Hansda(30 Yrs) S/O- Lt. Dinu Hansda of Vill- Tiyari, PS & Dist.- Bankura for lodging FIR against him.

Sir,

In producing herewith, the arrested accused persons namely Durgadas Hansda(30 Yrs) S/O- Lt. Dinu Hansda of Vill- Tiyari, PS & Dist.- Bankura along with seized articles i.e. 24 litres ID liquor in 12 plastic bottle (each bottle contained 2 litres) in which value of (24X140= Rs. 3,360/-), I beg to report that today i.e. on 13.06.2024 at 19:15 hrs, I ASI Khitish Chandra Gorai of Bankura PS during my mobile duty received a secret and credible source information that one person was selling ID liquor at Tiyari village under PS & Dist.- Bankura by keeping in a big bag without any valid license. Over this source information, I along with force had been to Tiyari village at 19:45 hrs to work out the information. I along with force surrounded the PO & found that one person was selling liquor beside the Bankura- Purulia Main road near Tiyari village and some persons were purchased liquor from him. I along with force held raid, but on seeing Police team all purchaser were fled away. However, we were able to apprehend the seller who was selling liquor. I asked him to produce valid license for selling liquor but he failed to produce any valid document. I asked him about his identity & he disclosed his identity as, Durgadas Hansda (30 Yrs) S/O- Lt. Dinu Hansda of Vill- Tiyari, PS & Dist.- Bankura. So, I arrested him at 20:05 hrs after observing all the legal formalities. I explained him the ground of arrest and I seized 24 liters ID liquor in 12 plastic bottle (each bottle contained 2 liters) in which value of (24X140= Rs. 3,360/-) under proper seizure list duly signed by the witness and also labeled the same. I collected 500 ml ID liquor from said one bottle in a plastic bottle as sample and sealed with gala.

Under the above circumstances, I pray before you that a specific case may kindly be registered against the arrested accused person namely Durgadas Hansda(30 Yrs) S/O- Lt. Dinu Hansda of Vill- Tiyari, PS & Dist.- Bankura under proper section of Law.
