I hereby declare that, I am Dinesh Kumar Yadav ,S/O-Ramjee Yadav viii+ po- Sarna ps-Sattapur Dist- Bhojpur State-Bhir,& Present address is- Maan concast Pvt Ltd Barjora ,Work as a storekeeper as per company order.


On 27<sup>th</sup> May 2024 a lorry which vehicle no is WB 41K 0461 came to the company with loaded sponge iron (pellet) around evening. On 28<sup>th</sup> May 2024 in the morning the vehicle entered by the company ordered for unloading the goods (pellet) <sup>on same day of about the 4:30 P.M</sup> After Unloading the goods and sweeping the remaining goods the driver suddenly drove due to rush & negligence driving at high speed and hit some transformer radiator which was kept near our company office.
