Subject: Prayer for registering a cog case.

Sir,

In producing herewith, the apprehending arrested person namely Bapi Bagdi (40yrs) s/o Lt Baghirath Bagdi vill-Baburdanga, PO-Pakhanna P.S- Barjora, Dist- Bankura along with seized articles viz.

- i) 01(one) Lathi from the possession of arrested accused person at Gopalpur sand ghat.
- ii) 03(Three) pieces Lathi, 02(two) pieces Iron rod, 05 (five) pieces of brick bats from the P.O at Gopalpur sand ghat.
- iii) 04(four) pieces Lathi, 01(one) pieces Iron rod, 01(One) red colour Hero Honda Hunk Motorcycle bearing Registration No WB68E 5974 & some broken glasses of Govt. vehicle bearing registration No WB42S 1503 from the Chandai morh.

I beg to submit that i.e. on 13.06.2024 at 17.15 hrs received a telephonic information from SIM No 9233300777 that one JCB khalasi of Gopalpur sand ghat namely SK Mahir Hossain (19 Yrs) S/o- Sk. Niyamat Hossion of Jaguli Para, PS- Galsi, Dist- Purba Bardhaman drowned while bathing with others into Damodar River at Gopalpur sand ghat under Pakhanna GP PS-Barjora Dist-Bankura some time ago. Accordingly, the matter was diarized vide Barjora PS GDE No.576 dated 13.06.24. Then, the Police personnel of Pakhanna Police Camp under Barjora PS immediately reached the spot vide Pakhanna Police Camp CC no-35/24 Dated 13.06.2024 and tried their best efforts to find out the sunken body by engaging local divers & Civil Defense rescue operation team, Bankura to conduct search. At that time, some local inhabitants led by one Jiarul SK, S/O Sadak SK of village Chandai, PS- Barjora tried to create disturbance to arise law and order in the locality in order to hamper the rescue operation and blaming to the legal sand ghat owner. However, Again, the rescue operation started though Civil Defense team, Bankura and Disaster Management team, 13th BN, Bankura and local divers since from today i.e 14.06.2024 morning under control of officer & force of Pakhanna Police Camp as well as Barjora PS detailed vide Pakhanna Police Camp CC no 36/24 dated 14.06.2024 & Barjora PS CC no.1797/24 dated 14.06.2024. After that, at about 15:35 hrs, the dead body of the drowned person was traced out approx. 150 mtrs. away from where the person was sank. Then, while the on spot Police picked up the dead body into the Police vehicle for immediate shifting to Barjora SSH, at that moment, the following accused persons namely 1)Paltu Bauri S/o- Ashok Bauri 2) Laltu bauri S/o- Ashok Bauri 3) Paresh Bauri @ Dabla S/o- Buro Bauri 4) Shibu Bauri S/o- Lt. Bahadur Bauri 5) Lakhan Bauri S/o- Lt. Ananda Bauri 6) Naru Bauri S/o- Jahar Bauri 7)Arun Bauri S/o-Bhim Bauri all of Vill- Etapara, Pakhanna, PS-Barjora, Dist-Bankura 8) Bapi Bagdi s/o Lt Baghirath Bagdi Vill-Baburdanga PS-Barjora, Dist-Bankura and 50/60 unknown others led by Jiarul SK S/o- Sadak SK of village Chandai, PS- Barjora assembled there unlawfully being armed with lathal weapons, iron rod, etc., showing agitation and

intentionally restrained the Police to discharge their lawful duty and made an obstruction to move Police vehicle carrying with the body of the drowned person from the spot. In spite of the repeated request for dispersing them from the spot, they pay not any heed, rather they started abusing the Police in filthy languages. Then there was no other alternative, on being urged off on spot Police, again the officers & force were reinforced at the said place vide Barjora PS CC no 1798/24 dated.14.06.2024 and then the unruly mob became more agitated seeing the arrival of Police and used slang language to them. Then, all statutory warnings were given to those unruly mobs to disperse from the spot, but they pay not any heed rather they started pelting brick bats aiming to Police. Then Police chased them and able to apprehend the accused namely Bapi Bagdi as mentioned above and seized one lathi from his possession though the rest others managed to flee away. During interrogation to the detained person, he confessed his guilt and totally corroborated the names of other accused persons as stated above responsible for committing the offence. Accordingly, he was arrested on the spot, observing all the formalities of arrest. Besides, 5(five) pieces of brick bats, 03(Three) pieces Lathi, 02(two) pieces Iron rod were also seized from the spot and the body of drown person was sent to Barjora SSH through police ambulance. Again, raid was conducted with arrested accused persons and as Shawn by him, another accused, namely Jiarul SK S/o- Sadak SK of village Chandai, PS- Barjora who took a leading part for committing the offence, was apprehended from Pakhanna Battala. Then both the accused persons were moved to Barjora Police Station under proper escort of SI Ashok Dey and force five in numbers through Police mobile van having Regd. No WB42S 1503. But, on the way to PS at Chandai village morh under Barjora PS, the following accused persons namely (1) Ajim Mondal S/o- Rohim Mondal (2) Monowar@ Ustar SK S/o- Lt. Hanif SK (3)Rustam SK S/o- Hanif SK (4)Rahim Mondal S/o- Lt. Jamaluddin Mondal (5)Rajob Ali SK S/o- Adul SK (6)Amjad SK S/o- Mohed SK (7)Azaruddin Mallick S/o- Nabiruddin Mallick (8) Kurban @ Tanuddin Mondal S/o- Fatick @ Joshimuddin Mondal all of vill- Chandai PS- Barjora, Dist-Bankura and 35/40 unknown others including females unruly mobs being armed with lathi, Iron rod, etc were assembled in the spot and made a resistance to the police van by barricading road in view of taking away the apprehended persons. Then Police of mobile van requested them several times and tried to convince them explaining the ground of justification of apprehension for maintaining the peace and tranquility in the area. But they didn't pay any heed rather, again they assembled so many other persons from their village at Chandai Morh. After that, they become more furious, and they forcibly used criminal force on the Police and dragged the Police officer out of the Police van in spite of giving all statutory and cautionary alarming to them for dispersing from the spot immediately but the unruly mob all of them committed attack on the Govt. Police van also and stricked the Police vehicle with bamboo lathi, broken the window glass of driver side eveng started to assault the police with bamboo lathi and iron rod aiming to kill them and able to snatched away the apprehended accused Jiarul SK S/o- Sadak SK of village Chandai, PS- Barjora. After that Jiarul SK S/o- Sadak SK of village Chandai, PS- Barjora also hit on my head by iron rod, and to protect my head, I raised hand and received injury on my wrist. Female crowd began to scratch on body parts and others punching on our chest. The mob started to threaten the police personnel, saying to set out fire on the police van. By this time, on being informed, the officers & force immediately reached at the spot and chased the unruly mob and dispersed them from the spot. The arrested accused Bapi Bagdi couldn't be able to escape. 04(four) pieces of Lathi, 01(one) pieces of iron rod, 01(one) red colour Hero Honda Hunk Motorcycle bearing Registration No WB68E 5974 & some pieces broken glasses of Govt. vehicle bearing registration No WB42S 1503 were also seized from the 2nd PO at Chandai village morh under Proper seizure list. In this incident, C/1125 Laxmikanta Mudji, C/2118 Subhajit Manna, C/2116 Susanta Paira,

NVF/0362 Uttam Guin, NVF/0351 Kapil Mishra and driver CD/173 Anup Kr. Mondal including me sustained injuries on our persons and rescued with the help of other police personnel after being reinforced at the spot and the injured Police personnel were treated at Barjora SSH.

On further interrogation of the arrested accused person, he admitted that they were assembled at sand ghat since tomorrow to create agitation and led to prevailing tension in the locality over the issue of drowning incident by planning with a view to their personal wrongful gain and he also confessed his guilt.

Therefore, I am praying to your good self that a specific case under proper section of law may kindly be registered against the accused person (1) Bapi Bagdi (40yrs) s/o Lt Baghirath Bagdi vill-Baburdanga PO-Pakhanna P.S- Barjora, Dist- Bankura (arrested) (2) Paltu Bauri S/o- Ashok Bauri (3) Laltu bauri S/o- Ashok Bauri (4) Paresh Bauri @ Dabla S/o- Buro Bauri (5) Shibu Bauri S/o- Lt. Bahadur Bauri (6) Lakhan Bauri S/o- Lt. Ananda Bauri (7) Naru Bauri S/o- Jahar Bauri (8) Arun Bauri S/o- Bhim Bauri all of Vill- Etapara, Pakhanna, PS- Barjora, Dist-Bankura and (9) Jiarul SK S/o- Sadak SK (10) Ajim Mondal S/o- Rohim Mondal (11) Monowar @ Ustar SK S/o- Lt. Hanif Seikh (12) Rustam SK S/o- Hanif SK (13) Rahim Mondal S/o- Lt.
