Sir,

On 13.06.2024, on getting information from a reliable source, I, Sri Pradip kumar Ghosh(s/o-Purnendu Kumar Ghosh), Forest Range Officer/Gangajaghati Range along with my staff went to Barjuri Protected Forest area at Mouza-Barjuri, JL No-137, and found that about 500(five hundred) cft stone boulders (used for construction of Gully Plugging works) have been stolen after dismantling and uprooting(photocopies attached) the Gully Plugging construction. Gully plugging work is executed for soil and water conservation. After a proper inquiry and searching, it has been detected that the said theft of 500(five hundred)cft stone boulders have been carried out from that Protected Forest area and stored near Barjuri jor, a small stream (situated in between Barjuri and Ramkanali Road) to construct a check dam funding by Agri Irrigation department. It is also reported that Sri Debiprasad Kundu, engaged as a contractor to construct that said Check dam, is solely responsible for that theft of 130 cft. stone boulders and plotted a conspiracy to dismantle sixteen numbers of gully plugging and stolen that stone to use it entirely for undergoing construction of the said check dam near Barjuri.

In the light of the foregoing averments of the instant complaint, your good self is requested to take cognizance of the instant complaint and swing into action by invoking appropriate section of law against the said perpetrator Debiprasad Kundu (Father name and Address not known) for his involvement in theft of Government produces and dismantling of Government funded construction works.
