Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accd. person namely Achinta Nandi (38 yrs) s/o. Ranjan Nandi of vill- Sukjora, PO- Gelia, PS- Joypur, Dist. Bankura with the following seized articles along with seized articles as per seizure list I beg to submit that today i.e., on 03.06.2024 at 13:45 hrs while I was performing mobile duty CC no.1788/24 at that time I received an information from duty officer vide GDE no. 108 dtd. 03.06.2024 that one person is selling illegally ID liquor in his house to common people in exchange of money. Accordingly I shared the information to OC Joypur PS and as per his direction I ASI Rajib Banerjee along with C/1112 Lalit Kishore Mahata and NVF/ 76 Aditya Pal proceeded to sukjora village, at about 18:10 hrs as soon as we reached at the house of said Achinta Nandi, on seeing the police party the common people fled away from the spot and also he tried to fled away. However we could manage to apprehended him. On being asked he failed to give any satisfactory answer about his such behavior. Then I searched his house in his presence. On search 1) 01 nos. of 20 ltrs. white colour jarricane filled with a liquid smells like I.D liquors containing 20 ltrs. 2) 20 nos. of plastic pouch containing approx 200 ml. liquid smells like I.D liquors in each pouch was found inside his house. On being asked he failed to produce any valid documents for stocking such huge amount of illegal liquor in his house. Thereafter I collected 500 ml of ID liquor as sample in separate bottle from 20 ltrs. white colour jarricane filled with a liquid smells like I.D liquors containing 20 ltrs. and seized the said articles under proper seizure list followed by proper packaging, sealing & labeling duly signed by the witnesses and accd. person. As said Achinta Nandi has committed an offence which attracts sec. 46 of Bengal Excise Act 1909. I arrested him under proper memo of arrest after maintaining all sorts of norms and guidelines regarding arrest.

Therefore I pray that necessary steps may kindly be taken against the accd. Achinta Nandi (38 yrs) s/o. Ranjan Nandi of vill- Sukjora, PO- Gelia, PS- Joypur, Dist. Bankura under proper section of law.
