Sub:- Prayer for registering a specific case against the arrested accd. person namely Miraj Sekh (21 yrs) s/o Jiarul Sekh of vill- Vitsayer, PS- Joypur, Dist- Bankura under proper section of law.

Sir,

In producing herewith the arrested accd. person namely Miraj Sekh (21 yrs) s/o Jiarul Sekh of vill- Vitsayer, PS- Joypur, Dist- Bankura along with the seized articles i.e., (1)one black color TVS motor cycle bearing reg. no- WB88/4448 chassis no- MD625MF52E1K12655 (2) one improvised iron made revolver covered with iron butt, iron body and barrel (Total length approx. 23 cm ; butt 8 cm, barrel 11.3 cm , body 9.5 cm) having 1 chamber with trigger & firing pin and (2) two rounds of revolver ammunitions; following numbers/ words are noted on the rim (back side) of the cartridges " OK 97 Z6 " on the both ammunitions. I beg to submit that on 13.06.2024 at 18.05 hrs received a information Joypur PS duty officer that one veteran criminal namely Miraj Sekh s/o Jiarul Sekh of vill- Vitsayer, PS- Joypur, Dist- Bankura has kept one prohibited arms in his house. Accordingly the matter has been diarized vide Joypur PS GDE No. 482 dated 13.06.2024 and as per your direction myself along with force C/1669 Anadi Saha, C/184 Nayan Gorai, all of Joypur PS left Joypur PS with govt vehicle for near Hetia High School hostel ground to work out the information. Vide Joypur PS GDE No. 482 dated 13.06.2024 and Joypur PS Spl CC No. 120/24 dated 13.06.2024. Myself along with my accompanied force reached at near Hetia High School hostel ground above noted accd. person at about 18:25 hrs reached at near Hetia High School hostel of the suspected accused Miraj Sekh. Seeing police one person was trying to flee with motor cycle from the Hetia High School hostel ground. After a hot chase, we managed to apprehend him. On being interrogated he disclosed his identity as Miraj Sekh (21 yrs) s/o Jiarul Sekh of vill- Vitsayer, PS- Joypur, Dist- Bankura. I searched his persons thoroughly and during search I found one improvised arms (revolver) at his motor cycle's digi and two rounds ammunitions in his left side pocket. I seized the arms and ammunition including motor cycle under proper seizure list duly signed by the witness. As no people came forward to put his signature as witness on the seizure list, my accompanied force who witnessed the seizure, put their signature as witness of seizure.

I interrogated him thoroughly and asked how he got those arms and ammunitions and motor cycle in his possession, but he cannot give any satisfactory answer in this regard. He also failed to produce any relevant document in support of the arms and ammunitions and motor cycle in his possession. He told that the motor cycle belongs to one of his close relative.

Thereafter, I arrested him under proper memo of arrest as per the procedure laid down in Cr.P.C and supplied a copy to him and followed the latest guidelines of the Apex Court. Then brought the arrested accd along with the seized articles to PS. After arrest medical check up of the accused has been done at Joypur BPHC. As the arrested accd. as noted above was found keeping firearms with ammunitions and motor cycle without any valid authority in his possession he is liable to be punished under proper section of law under the Arms Act- 1959.

Therefore, I pray that a specific case may kindly be registered against the arrested person namely Miraj Sekh (21 yrs) s/o Jiarul Sekh of vill- Vitsayer, PS- Joypur, Dist- Bankura under proper section of law and necessary arrangement be made for its proper investigation.
