Aditya Kumar Kundu., A.E. & Station Manager., Kotulpur Customer Care Centre, WBSEDCL being empowered by Electricity Act 2003 ammended in 2007 do hereby. lodge a complaint against accused person. Nimai Ballabh (user)., S/O- Late Umapada Ballabh., Vill.- Konpa, PO - Kotulpur., P.S- Kotulpur, Dist:-Bankura, for committing theft of electricity by way of making loop connection from existing. One no two core. PVC service cable for the purpose of their Domestic use where One no. Live Domestic connection already exists bearing Con ID- 233099817, which interferes the actual or proper registration of Meter.

On getting the source information of theft of electricity myself along with Gautam Kr Dolui, Gr-I T.S.H of Kotulpur CCC & Sri Biplab Mandi , D.E , S & LP & Sri Sankar Ch Dana , Special Officer , S & LP, Bankura Region Office today 19.06.2024 between 12:45 hours to 13:05 hours inspected the Domestic premises of accused person Nimai Ballabh (user) , S/O- Late Umapada Ballabh , Vill.- Konpa, PO - Kotulpur , P.S- Kotulpur , Dist:- Bankura .

During inspection it was detected that the said accused user was enjoying electricity unauthorizedly by way of oop connection from existing One no two core. PVC service cable for his Domestic purpose where One no. live Domestic connection already exists bearing Con ID- 233099817. Thus the accused Nimai Ballabli (user). S/O- Late Umapada Ballabh, Vill.- Konpa, PO - Kotulpur, P.S- Kotulpur, Dist:- Bankura violated the existing rules of Electricity Act 2003 (amended in 2007).

Inspection report prepared on the spot and assessed consumption of load which was detected as 2.0 (Two) KW. The details have mentioned in the Inspection report.

I directed Gautam Kr Dolui , S/O- Lt Probhas Dolui to disconnect the Live Domestic Service Connection and remove the portion of service cable bearing Con_Id 233099817. Accordingly he disconnected the PVC cable from the L.T.O.H line as per direction. I seized the portion of the service cable for preparation of seizure list from where he tapped. I fixed up the responsibility to the accused user Nimai Baliabh (user) , S/O- Late Umapada Ballabh , Vill.- Konpa, PO - Kotulpur , P.S- Kotulpur, Dist:- Bankura with the help of my source , since the perpetrator was not present at the time of my nspection as well as detection of offence.

It is well proved that the said accused Users Nimai Ballabh (user), S/O- Late Umapada Ballabh, Vill-Konpa, PO - Kotulpur, P.S- Kotulpur, Dist:- Bankura, was committing the theft of electricity as he was using electricity unauthorizedly by making loop connection from Existing service connection cable before meter box which interferes the actual or proper registration of Meter. As such he liable for persecution U/S 135(1) (b) of Electricity Act 2003 (amended in 2007).

Kindly treat this complaint as F.I.R.
