Sub:- Prayer for lodging FIR against Kajal Mondal (approx. 29 Years), S/O- Shyamapada Mondal of Village-Sitarampur , P.S- Mejia, District- Bankura.

Sir,

In producing herewith the arrested accused person namely Kajal Mondal (approx. 29 Years), S/O- Shyamapada Mondal of Village-Sitarampur , P.S- Mejia, District- Bankura along with seized articles **(1) Seventeen (17) bottles of Country Spirit styled as Captain 60° UP containing 600 ml each, MRP- RS 155/- per bottle, (2) One bottle (Country Spirit styled as Captain 60° UP containing 600 ml, MRP- RS 155/-) collected as sample from SL No- 1** and duly sealed and labeled by me I, SI Kausik Kumar Das S/o Late Ajit Kumar Das of Mejia P.S do hereby lodge complaint against one Kajal Mondal (approx. 29 Years), S/O- Shyamapada Mondal of Village-Sitarampur , P.S- Mejia, District- Bankura to the effect that today i.e. on 26.06.2024 at about 18.45 hours in course of evening mobile duty vide Mejia P.S G.D.E. no-1009 Dt -26.06.2024 & C.C No-2419, received secret source information over phone that illegal selling of Country Spirit is going on at Sitarampur village at the house of Kajal Mondal. Accordingly, I informed the matter to O/C, Mejia P.S over phone and as per his kind permission, I along with my accompanying force namely C/1042-Sujit Kumar Sing, C/2664-Sanjoy Kumar Maji & NVF/0560-Subhas Sen left for Sitarampur village to work out the information.

On 26.06.2024 at about 19.05 hours, I along with my accompanying force reached at Sitarampur village at the house of Kajal Mondal and found some persons who were taking liquor from Kajal Mondal started to flee away. We chased them, but we could manage to detain one person. On being asked, he disclosed his identity as Kajal Mondal (approx. 29 Years), S/O- Shyamapada Mondal of Village-Sitarampur , P.S- Mejia, District- Bankura. I called some disinterested persons. In presence of some local people and police personnel searched the house of the detained person and found **Seventeen (17) bottles of Country Spirit styled as Captain 60° UP containing 600 ml each, MRP- RS 155/- per bottle.** On local enquiry, I came to learn that the apprehended person used to sell liquor illegally from his house and he is running this illegal business since long with a view to his wrongful gain. On being asked he failed to produce any valid documents in respect of the storing and selling of Country spirit. So I seized the same in presence of witnesses arranged to collect one bottle as sample, sealed and labeled the same. On several request, no local people came forward to sign the seizure list. Hence, finding no other alternatives, I took signature of my accompanying force namely C/1042-Sujit Kumar Sing, C/2664-Sanjoy Kumar Maji & NVF/560-Subhas Sen all of Mejia P.S on the seizure list as seizure witnesses. The seizure of the above articles was made in between 19.15 to 19.35 hrs and copy of seizure list has been provided to the detained person. Thereafter I arrest the accused person namely Kajal Mondal (approx. 29 Years), S/O- Shyamapada Mondal of Village-Sitarampur , P.S- Mejia, District- Bankura. The total value of the article seized is Rs. 2635/- only.

I, therefore, pray before your kind self that a specific case may kindly be registered against the accused person namely Kajal Mondal (approx. 29 Years), S/O- Shyamapada Mondal of Village-Sitarampur , P.S- Mejia, District- Bankura under proper section of law and arrange for its investigation.
