Subject: Lodging of FIR against user accused MANIK GHOSH, S/O- KANAI GHOSH, Vill- KESHABPUR(NATUNGRAM), P.O.-PARULIA P.S- Patrasayer, Dist- Bankura for theft of electricity by direct hooking u/s 135(1)(a) of Electricity Act 2003 and Electricity (Amendment) Act-2007.

Sir,

I BIKASH MANDAL, S/O- SRI. NALINI KANTA MANDAL, Station Manager of the Patrasayer Customer Care Centre, WBSEDCL being authorized under the Electricity Act-2003 and Electricity (Amendment) Act-2007, do hereby lodge complaint against user accused, MANIK GHOSH S/O- KANAI GHOSH, Vill- KESHABPUR(NATUNGRAM), P.O.-PARULIA, P.S- Patrasayer, Dist- Bankura for theft of electricity by Direct hooking of electrical network with the help of hooking device from nearby input service wire (power line, although there is another one no. service connection exist bearing Con. Id - 204271277) of WBSEDCL, u/s - 135(1)(a) of Electricity Act 2003 and Electricity (Amendment) Act-2007, as Stated here under:-

That on 25.06.2024 in between 01:15 PM and 01:35PM Myself BIKASH MANDAL, S/O- SRI. NALINI KANTA MANDAL along with, Sri. Biplab Mandi, D.E, S&LP and Sankar Ch. Dana, S.O, S&LP both are from Bankura Regional Office, WBSEDCL on the basis of secret source information inspected the DOMESTIC premises of user accused, MANIK GHOSH, S/O- KANAI GHOSH, Vill- KESHABPUR(NATUNGRAM), P.O.-PARULIA, PS-Patrasayer, Dist- Bankura and during inspection it was found that user accused MANIK GHOSH were using electricity unauthorizingly and dishonestly in his DOMESTIC premises by Direct hooking of electrical network of WBSEDCL with the help of two nos single core PVC cable found one end in bend condition to use as hooking device. So, he has committed theft of electricity and liable for prosecution u/s. -135(1)(a) of Electricity Act-2003 and Electricity (Amendment) Act-2007.

Inspection report prepared on the spot as well as preparing seizure list and assessed the load which comes to 0.8 KW. I directed Sri. Sourav Bhattacharya, Sr. T.S.H, along with staff of Mobile Van(Tech. person) to dehook the hooking cable fitted with LTOH line of WBSEDCL. He accordingly dehooked the same and seized the same and seizure list was prepared accordingly. Copy of Seizure list and Inspection report could not be handed over to the accused person nor his representative refused to accept that. WBSEDCL provided him electrical connection vide con id and his service connection was also disconnected by our staff.

The inspection team left the site at 01:40 PM on 25.06.2024 after completion of inspection & raid.

It is well proved that user accused MANIK GHOSH, S/O- KANAI GHOSH, Vill- KESHABPUR(NATUNGRAM), P.O- PARULIA, P.S- Patrasayer, Dist- Bankura committed theft of electricity by Direct hooking of electrical network of WBSEDCL as such he is liable for prosecution u/s 135(1)(a) of Electricity Act 2003 amended in 2007.

So you are requested to treat this complaint as F.I.R.
