Sub: FIR against theft of electricity

Sir.

I do hereby lodge my complaint empowered by the Electricity Act-2003 and its Amendment Act'2007 against JAYANTA MUDI, C/O- MAHANTA MUDI residing at Vill- Ektali, PO- Motgoda, P.S-Raipur Dist-Bankura, for committing theft of electricity and thereby he is liable to prosecute U/S 135(1)(a) of Electricity Act, 2003 (Amendment Act, 2007) as stated hereunder.

Today, i.e. on 21.06.2024 at 12:30 I, Najmul Hoda, DE & SM, S/O- Lt. MD. Muslim Tajir, Monoranjan Hazari (Linesman) S/O Banshi Hazari, Harisadhan Karmakar(Sr. TSH) S/O Lt. Indrajit Karmakar & Babula Mahato S/O- Arjun Mahato all of Raipur CCC along with Biplab Mandi, DE(E) S&LP wing & Sankar Ch Dana, SO (s&lp), BNK Region office inspected the commercial premises at Vill-Ektali.

During inspection at the commercial premises of JAYANTA MUDI at Vill- Ektali, PO-Motgoda, P.S-Raipur Dist-Bankura it was found that he was using electricity dishonestly and unauthorizedly by way of direct hooking from LT 4 wire line of WBSEDCL situated at about 200mtr approx from his poultry farm & run various electrical appliances. Thus huge revenue of WBSEDCL lost.

As theft of electricity was detected, I with the help of my staffs disconnected the unauthorized line and dismantled some portion of two core aluminium black colored 4sqmm PVC covered hooking cable of approx length of 10 mtr under a proper seizure list duly signed by our inspection team members.

The seized material was packed, labeled and sealed at the spot. Inspection team left the aforesaid

location at about 13:00 hrs after completion of all formalities.

So, accused JAYANTA MUDI, C/O- MAHANTA MUDI residing at Vill- Ektali, PO-Motgoda, P.S-Raipur Dist-Bankura, has committed an offence for which he is liable to prosecute U/S 135 (1)(a) of the Electricity Act 2003 and its Amendment Act 2007.

Hence you are requested to take cognizance of this complaint and to treat this as FIR.
