Sub: FIR against theft of electricity

Sir,

I do hereby lodge my complaint empowered by the Electricity Act-2003 and its Amendment Act'2007 against **KESAB MUDI, C/O- RATHILAL MUDI** residing at **Vill-Ektali, PO- Motgoda, P.S-Raipur Dist-Bankura**, for committing theft of electricity and thereby he is liable to prosecute U/S 135(1)(a) of Electricity Act, 2003 (Amendment Act, 2007) as stated hereunder.

Today, i.e. on **21.06.2024** at **13:10Hr** I, Najmul Hoda, DE & SM, S/O- Lt. MD. Muslim Tajir, Monoranjan Hazari (Linesman) S/O Banshi Hazari, Harisadhan Karmakar(Sr. TSH) S/O Lt. Indrajit Karmakar & Babula Mahato S/O- Arjun Mahato all of Raipur CCC along with **Biplab Mandi, S&LP wing, & Sankar Ch Dana, SO (s&lp)**,BNK Region Office inspected the domestic premises at Vill- Ektali.

During inspection at the domestic premises of **KESAB MUDI at Vill-Ektali, PO- Motgoda, P.S-Raipur Dist-Bankura** it was observed that he was consuming electricity dishonestly and unauthorizedly by way of direct hooking from nearest LTOH line of WSEDCL for construction of new house and during inspection it was observed that electricity used from approx 3 months to run various electrical appliances used for construction of house. Thus huge revenue of WSEDCL lost.

As theft of electricity was detected, I with the help of my staffs disconnected the unauthorized line and dismantled some portion of single core two no. yellow colored 3.5sqmm each alluminium cable of approx length 10mtr each under a proper seizure list duly signed by our inspection team members.

The seized material was packed, labeled and sealed at the spot. Inspection team left the aforesaid location at about 13:40 hrs after completion of all formalities.


So, accused **KESAB MUDI, C/O- RATHILAL MUDI** residing at **Vill-Ektali, PO- Motgoda, P.S-Raipur Dist-Bankura**, has committed an offence for which he is liable to prosecute U/S 135 (1)(a) of the Electricity Act 2003 and its Amendment Act 2007.

Hence you are requested to take cognizance of this complaint and to treat this as FIR.
