Respected Sir,

In producing herewith one arrested accused person namely Manoranjan Bauri (M/38Y), S/O - Lt. Nimai Bauri of Vill - Dihipara, P.S - Sonamukhi, Dist - Bankura and one seized Blue colour tractor styled as 'Swaraj' having Reg. no. WB 68AL /6209 having Engine no- DC 4007/SE002944, Chassis No- MBNAW53ADNCD15437 filled with sand attached with trolley under proper seizure list. The fact of the case is that, on 09.06.2024 at about 19:25 hrs I along with force was performing special evening mobile duty vide GDE No - 337, dated - 09.06.2024. That time I received a credible source information that, one tractor having Reg. No. WB 68AL /6209 was coming from Rangamati side to Sonamukhi side loaded with sand illegally. I informed the matter to I/C Sonamukhi P.S and as per his direction I along with my accompany force left for Rangamati side to work out the information. At 19:45 hrs I along with force reached at Basudebpur more, I found the suspected tractor having Reg. No. WB 68AL /6209 coming from the Rangamati side. I along with force stopped the tractor and found it loaded with sand in the trolley. I asked the driver to produce any valid documents regarding possession and transportation of the loaded sand. He failed to produce any valid documents in this respect. During interrogation he disclosed his identity as Manoranjan Bauri (M/38Y), S/O - Lt. Nimai Bauri of Vill - Dihipara, P.S - Sonamukhi, Dist - Bankura. He started to give different types of statements in different times whenever he was asked about the source of the loaded sands. After that I seized the tractor having Reg. No. WB 68AL /6209 loaded with sand in the trolley under proper seizure list duly signed by my accompany force. I also searched for independent public witnesses but none agreed to put their signature in the seizure list. After that I arrested him after maintaining all legal formalities regarding arrest and also observed the guidelines of N.H.R.C and Apex court. The sand loaded tractor has been kept at PS compound for safe custody.

So, I request you to lodge a specific case against the arrested accused driver namely Manoranjan Bauri (M/38Y), S/O - Lt. Nimai Bauri of Vill - Dihipara, P.S - Sonamukhi, Dist - Bankura and owner of the said tractor as per specific section of law and arrange for investigation.
