At that time of their presence to make a chaotic situation in the office premises, the technical personnel were already attended the docket.

Before asking and discussing the matter of their discontentment, the mob started thumbing upon office chair table with untold slangs and started to threaten the office personnel and even to the lady ones. Some of them started to throw meters here in and around the office campus. They were tried to discuss the inconvenience they face but all of them were in deaf ears to listen to. Such chaotic situation raised, now and then, in the office or outside of is being made the office personnel to attend their duty as well as maintain the consumer service with sincerely.

At the time, when the situation was going out of control and office personnel namely Sri Biswarup Lakshman, Jr. Engineer (Elec.) Grade-I- was physically assaulted and hackled, your police station was contacted over telephone and, with the active co-operation of your police officers; the exciting situation was brought under controlled.
