Sir,

In producing herewith the 05 arrested accused persons namely 1) Rahim Mondal (22Yrs) S/O- Rabial Mondal , 2) Asuruddin Mondal (24 Yrs) @ Chhutan @ Kota S/O- Abusupian Mondal , 3) Tajuddin Khan (48 Yrs) @Humo S/O- Lt. Mamud Ali Khan , 4) Alamin Khan (19 Yrs) S/O- Koder Ali Khan @ Bhutai , 5) Nur @ Yar Nabi Mandal (36Yrs) @ Ari S/O- Lt. Taher Ali Mandal all of Vill-Rajpur, PS -Taldangra, Dist -Bankura, and seized articles i.e. 1.One iron Rod approx. length 04'[feet], 2.One Tensor blade with frame, approx. length 1.5 [feet], 3.One 'Shabol' approx. length 02'[feet], 4.Iron wire approx length 20'[feet], 5. One iron made 'vojali' length approx. 02'[feet], I would like to draw your kind attention to the fact that on 22.06.24 at 01:05 hrs received information from credible source that a gang of dacoits have assembled at Cannel bridge at Loha jungle area near Thungla Village with a view to commit road Dacoity on 'Choubeta-Taldangra pitch Road' under Taldangra PS. Accordingly, I informed the matter to I/C Taldangra PS as well as duty officer of Taldangra PS which was diarized in Taldangra PS GD Book Vide Taldangra PS GDE NO-695, dtd- 22.06.24. As per direction of I/C Taldangra PS Myself along with force reached near Cannel bridge at Loha jungle area near Thungla Village, Choubeta-Taldangra Road and proceeded towards Loha jungle area near Thungla Village, leaving our vehicles at a distance, walked approx. 900 mtrs. & reached into Loha Jungle area in a concealed manner. There I found that a whispering was coming out inside the jungle. Myself along with force ambushed there & could see flashes of torch lights & smoking (biri) there. Accordingly myself with the help of accompanying force surrounded the specific area of the jungle in a concealed manner to verify the source information. In the darkness of night hours, I found few persons were sitting there inside the Loha Jungle area. I heard that they were making preparation for committing dacoity on road vehicles by placing iron wire tied across the road side trees. We reached near them by crawling and clearly heard their whispering talks which disclosed their plan for committing dacoity on road vehicles by making road blockade & causing fear of assault to the driver of vehicles and motor-cycles. Myself along with force secretly cordoned the place by crawling surreptitiously and from a close distance we disclosed our identity in full uniform, commanded them to surrender. It was on 22.06.2024 at about 01:45 hrs. night, when instead of surrendering, they started to run hither and thither but myself with the help of my accompanying force could manage to apprehend five of them but others were managed to escape with the help of darkness of night. On interrogation they disclosed their identity as 1) Rahim Mondal (22Yrs) S/O- RabialMondal , 2) AsuruddinMondal (24 Yrs) @ Chhutan @ Kota S/O- AbusupionMondal , 3) Tajuddin Khan (48 Yrs) @Humo S/O- Lt. Mamud Ali Khan , 4) Alamin Khan (19 Yrs) S/O- Koder Ali Khan @ Bhutai , 5) Nur @ Yar Nabi Mandal (36Yrs) @ Ari S/O- Lt. Taher Ali Mandal all of Vill-Rajpur, PS -Taldangra, Dist -Bankura. On thorough interrogation, above noted accd persons also confessed that their 3/4 companions could manage to escape from the spot. They assembled there with a view to commit road dacoity. I and my accompanying force offered our search to accd persons but they refused. Thereafter I thoroughly searched them & also the P.O. with the help of my accompanying force after arranging sufficient torch light. During searching I seized 1. One iron Rod approx. 04'[feet], 2. One Tensor blade with frame, approx. length 1.5 [feet], 3.One 'Shabol' approx. length 02'[feet], 4.Iron wire approx length 20'[feet],

5. One iron made 'vojali' length approx. 02'[feet] from them. I prepared seizure list & label duly signed by the witnesses & aced persons. I could not get any public witness as the time of seizure is late night, on 22.06.2024 in between 02:05 hrs. and 02:35 hrs. So, my accompanied force put their signature in the seizure list. The above noted accused persons failed to explain their such conduct for making assembly at such lonely place in the jungle. As there was a specific information, there was every reason to believe that the dacoits had assembled there and were preparing for committing dacoity on road vehicles. Accordingly, I arrested above noted accused persons namely 1) Rahim Mondal (22Yrs) S/O- RabialMondal , 2) AsuruddinMondal (24 Yrs) @ Chhutan @ Kota S/O- AbusupionMondal , 3) Tajuddin Khan (48 Yrs) @Humo S/O- Lt. Mamud Ali Khan , 4) Alamin Khan (19 Yrs) S/O- Koder Ali Khan @ Bhutai , 5) Nur @ Yar Nabi Mandal (36Yrs) @ Ari S/O- Lt. Taher Ali Mandal all of Vill-Rajpur, PS -Taldangra, Dist -Bankura a after maintaining all legal formalities guided by NHRC rule. I supplled a copy of seizure list as well as copy of Arrest Memo to arrested accused persons after obtaining his signature. I did not venture to take any public witness with us as we had specific information about the assembly of a gang of the dacoits with weapons.

On my arrival back to P.S. with 05(five) arrested accused persons with the seized alams, I produced them before you for starting a specific case against the arrested accused persons and 3/4 others. Kindly arrange its investigation & oblige.
