Sub: Prayer for lodging the FIR.

Sir,

With due respect I, ASI UdayBhanuBallav of Taldangra PS, Dist- Bankura , do here by lodge the Suo- Moto complaint against the following miscreants, namely 1) KarunaLayek, S/O- Lt. KhokanLayek, 2) TufanLayek, S/O- Sunil Layek, 3) AtuLayek, S/O- Lt. SudhirLayek, 15) SabitriLayek, W/O- LaxmikantaLayek, 16) JyotshnaLayek, W/O- MathurLayek, 17) Uma Layek, W/O- Ram Layek, 18) Sandhya Layek, W/O- MansharamLayek, 19) Krishna Layek, S/O- Haradhan and 20) KadamLayek, W/O- DhirenLayek, 21) Ranjan Layek, S/O- Sukumar, 22) Swapan Layek, S/O- Baul, 23) Chandan Layek, S/O- basu -- all of vill-Fakirdanga, PO- Chhagulia, PS-Taldangra, Dist-Bankura and 25/30 other unknown miscreants of the same locality to the effect that today on 22.06.24 at about 16:30hrs while I was engaged as 'Duty Officer' of this PS, found that the above noted miscreants along with 25/30 other unknown miscreants assembled with Iron Rod, Lathi, Branches of trees etc in their hand, forcefully entered inside PS compound by kicking the PS gate and forcefully entered inside the 'Duty Officer's Room. The on duty Sentry, LC/- 2047 Tapashi Roy tried to stop them but they assaulted her with fist and blows and with Lathi and pushed her away. Then I also tried to stop them but they also abused and assaulted me and started obstructing us from discharging govt. duty and started hue and cry and damaged govt. properties i.e. office Chair, Table glass, clay tub etc. Then I informed I/C, Taldangra PS and other officers and force and they rushed to the spot. After that they again asked them to stop such nuisance but they become more furious and started uproars and started scuffling and assaulted our police, as a result i) SI SaifulSk, ii) ASI UdayBhanuBallav (Me), iii) LC/- 2047 Tapashi Roy, iv) C/- 1294 Sanjib Acharya, v) C/- 1069 Karam Chand mandi, vi) HG62 ChandanGuli and some other police personnel - all of Taldangra PS sustained injuries on their persons and were admitted and treated in Taldangra Rural Hospital. Then after more officers and force of this PS reached the spot and disbursed the mob, thus the situation was brought under control and the miscreants fled outside the police station.

It is to be noted here that today on 22.06.24., SI Ashit Sal of Amdangra OP, PS- Taldangra conducted raid at Fakirdanga village under Taldangra PS to recover the VG and to arrest the FIR named accused person, namely RanaLayek @Lulka, S/O- RajibLayek in C/W Taldangra PS Case No- 58/24, Dtd- 28.05.24, U/S- 363/365 IPC but found that they were not present at his house. Then he arrested the father of the FIR named accused, namely RajibLayek, S/O- Lt. ShibuLayek after maintaining all legal formalities and brought him to the Taldangra PS and put him into the

Hazat. After that the above noted miscreants forcibly entered into the Taldangra PS, armed with Iron Rod, Lathi, Branches of trees etc. with a plan to forcibly take away the said arrested accused person from the custody of police station i.e. from Hazat.

Hence the above noted accused persons who all are verified to be notorious mob of the area, obstructed, abused, threatened police to deter in discharge of public functions Govt. duty and assaulted the uniformed police personnel, destructed police order, damaged Govt. properties, I do hereby lodge this complaint for starting a specific case against all the accused persons as noted above and arrange for its investigation.
