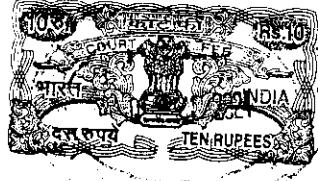

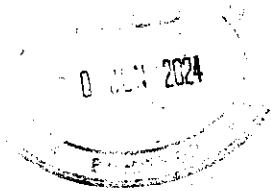

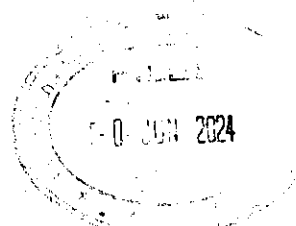

Complaint under section 156 (3) Cr PC against above named accused persons for the commission of offence under section 427, 323, 325, 354, 379, 380, 120B, 34, 506 IPC

The complainant most respectfully begs to state following:

On 1/06/2024 at about 7.30 am in the early morning accused persons no 1-3 were raising illegal and unauthorized construction over the suit plot L. R. Plot no: 521, R. S. Plot no: 521, district: Bankura, Sub-division: Bishnupur, Ps: Kotulpur, Mouza: Radhadamodorpur, JL no: 113, L. R. Khatian no: 311, area 0.07 acre that is seven Satak out of total 0.30 acre, Classified as Bastu, recorded in the name of erstwhile owner Hatem Bayen S/O late Subed Bayen surrounded by Radhadamodorpur Jumma Masjid on the western side, residential home of Lokman Bayen on the eastern side, one Pond/ Doba on the northern side, residential home Mohon Molla on the southern side of suit property upon which one TS case 27/2022 is sub-judice before Ld Civil Judge (Senior Division) At Bishnupur against accused person no 1 Abbari Ali Bayen S/O Late Hatem Ali Bayen resident at Village: Radhadamodorpur, Post: Balitha, Ps: Kotulpur, District: Bankura, Pin: 722141 and three others which is a partition suit, the complainant had cautioned them and advised them to refrain from doing such illegal act of raising construction over the suit plot. Be it is noted that said accused person no 1 against whom TS 27/2022 is sub-judice upon receiving summons of said case from Ld Court, defendant no 1 Abbari Ali Bayen had already appeared with duly filled up vokalatnama. Since then said illegal and unauthorized construction was stopped by said defendant immediately after receiving summons from Ld Court. Despite all said defendant Abbari Ali Bayen and his sons Hausar Ali Bayen, Sanuar Bayen, daughter-in-law Resma Bibi W/O Adam Ali Bayen, Hasina Bibi W/O Abbari Ali Bayen, Rokeya Bibi D/O Abbari Ali Bayen W/O Delowar Kha were all with a common object and common intention to kill the complainant and aged husband of the complainant, committed trespass inside residential house of complainant and her husband situated at Village: Radhadamodorpur, Post: Balitha, Ps: Katulpur, District: Bankura for cautioned them from raising illegal and unauthorized

construction over said suit plot, started assaulting the complainant, caused sprain on the right hand arm of the complainant, kicked her, assaulted her son Sabir Ali Middya, pressed his neck to gag him to kill, and also assaulted my daughter-in-law Motahara Bayen W/O Saidulla Bayen, with whom Hausar Ali Bayen, Sanuar Bayen, Abbari Ali Bayen had committed outrage of her women modesty by opening her printed sari of red color, torn her blouse, committed theft of her chain made of gold of one bhoori from her neck amounting Rs 65,000. So after happening of such gruesome incidence, the complainant along with her son and daughter-in-law went to lodge complaint with the officer-in-charge, Kotulpur Police Station and also fact that O.C. had accepted complaint due to political interference O.C. Kotulpur Police Station had suppressed complaint of the complainant, which activity on the part of O.C. had inspired them. Again on 7/06/2024 at about 8.10 am in the morning those culprits upon trespassing in the residential house of the complainant, assaulted the complainant, sister-in-law namely Chinta Bayen W/O Rahamat Bayen and also to Motahar Bayen W/O Saidulla Bayen, intimidated to set fire residential house of the complainant, intimidated to commit rape upon Motahar Bayen for lodging complaint against them while all male members in the family of the complainant went for work outside home and village. Aggrieved by this the complainant is being compelled to send this copy of complaint to O.C. Katulpur Police Station through registered post with acknowledgment due for taking legal action which O.C. has not yet been initiated against them.

Prayer

Hence it is most graciously being prayed that your Honor may be pleased to pass an order upon Officer-in-charge, Kotulpur Police Station for treating Complainant as FIR under section 156 (3) Cr PC and take necessary legal action against all the above named culprits Abbari Ali Bayen and his sons Hausar Ali Bayen, Sanuar Bayen, daughter-in-law Resma Bibi W/O Adam Ali Bayen, Hasina Bibi W/O Abbari Ali Bayen, Rokeya Bibi D/O Abbari Ali Bayen W/O Delowar Kha for assault, infliction of grievous hurt, and simple hurt, commission of house trespass, conspiracy to hush up ancestral property by raising illegal and unauthorized construction over the suit plot which is sub-judice, outrage of women modesty, committed theft of gold chain, intimidated to set fire our residential house, intimidated to commit rape and many more, bring all those culprits under justice.
